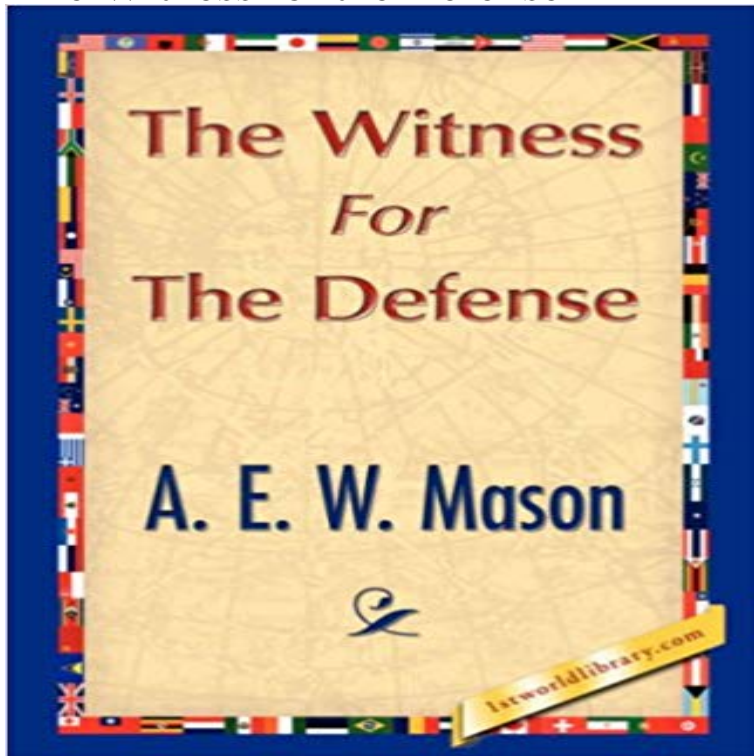


The Witness for the Defense
